VII. FIRST READINGS:

1. Consideration of a Resolution of support for the 2008 Transportation Enhancement Grant.

2. Consideration of an Ordinance to rezone property located on the east side of Riverside Drive, just south of Washington Street from I-O/FH (Wholesale and Warehousing/Flood Hazard) District to I-3/FH (General Industrial/ Flood Hazard) District containing 4.33 acres, more or less, submitted by JSM Company, Inc.

3. Consideration of an Ordinance to rezone property located on the east side of North Highland Avenue, just south of Highland Memorial Gardens Cemetery from RG-1 (General Residential) District and RS-1 (Single Family Residential) District to B-5 (Highway Business) District containing 7.49 acres, more or less, submitted by Bob Pearce.
